



2020 Code of Ethics

Subscribe to the Code!

It's your duty to fellow REALTORS®, clients, and customers.

To call yourself a REALTOR®, you must join the National Association of REALTORS®, and a state and local REALTOR® Association, and subscribe to the NAR Code of Ethics. This means NAR requires you to take a Code of Ethics class when you join and every three years as set by NAR.

You'll remain in "Pending/Provisional" status until you complete an approved NAR Code of Ethics course. Complete a course within 90 days of joining to become an "Active" member. This means you're officially a REALTOR® and can begin using the REALTOR® trademark. You'll also appear in both the online WeSERV and NAR member directories.

Attend the **New Member Orientation & NAR Code of Ethics** at the WeSERV West Valley location to gain information about the three Associations you've joined, take the REALTOR® oath, and complete the NAR Code of Ethics requirement. You'll also earn 3 hours Commissioner's Standards CE credit for your license renewal. You can also take the Code online; however, not all online Code of Ethics classes include CE credit and most include payment to attend.

Remember, taking a Code of Ethics is a requirement of membership. If you haven't taken a Code of Ethics class and submitted your certificate to WeSERV within 90 days of joining, WeSERV is required to terminate your membership. This means you will lose access to valuable real estate tools like MLS, eSign, TransactionDesk®, ActiveKEY, etc. You will also no longer be able to call yourself a REALTOR®. Don't let this happen. **Take the Code within 90 days of joining.** You are also required to take the Code every three years as set by NAR; by December 31, 2021, 2024, 2027, 2030, 2033...
